## SHORT MINUTES OF ORDER

The Court orders that:

1. The directions hearing listed for 21 August 2020 be vacated.
2. In accordance with the orders of Justice Ball dated 14 August 2020, the Plaintiffs to file and serve the Second Further Amended Summons and Further Amended Commercial List Statement in the form of schedule A and schedule B respectively to the Notice of Motion dated 1 July 2020 on or before 21 August 2020.
3. On or before 21 August 2020, the Plaintiffs serve on the proposed Twelfth and Thirteenth Defendants, a copy of:
  - 3.1 all the pleadings filed and served in these proceedings, including any subpoenas for production issued in the proceedings;
  - 3.2 any request by any defendant for particulars of any previous version of the Plaintiff's Commercial List Statement, and any response to such a request;
  - 3.3 any request by the Plaintiffs for particulars of any defendant's List Response, and any response to such a request;
  - 3.4 all discovery provided by the parties in these proceedings; and
  - 3.5 all documents referred to in the Further Amended Commercial List Statement, not otherwise provided.
4. On or before 21 August 2020, the Plaintiffs serve on the eighth defendant:
  - 4.1 all evidence served by the parties in these proceedings; and
  - 4.2 all discovery provided by the parties in these proceedings, except for the tenth and eleventh defendants.
5. The Defendants to file and serve any Commercial List Responses to the Further Amended Commercial List Statement by 16 October 2020.
6. The proceedings be listed for directions on 23 October 2020.
7. Liberty to restore on 3 days' notice.
