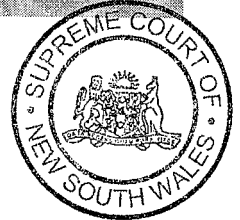

TYPE OF CLAIM

Commercially misleading conduct

REPRESENTATIVE ACTION

- 1 This proceeding is commenced as a representative proceeding pursuant to Part 10 of the *Civil Procedure Act 2005* (NSW) by the Plaintiff on its own behalf and on behalf of persons who:
- a. acquired an interest in ordinary shares in the defendant, RCR Tomlinson Limited (In Liquidation) (the **Company**):
 - i. pursuant to the Entitlement Offer (the **Entitlement Offer**) set out in the prospectus lodged with the Australian Securities Exchange Limited (**ASX**) on 28 August 2018 (the **Prospectus**); and/or
 - ii. during the period from 31 August 2018 to 12 November 2018 inclusive (the **Relevant Period**), on the financial market operated by the ASX;
 - b. suffered loss or damage by or resulting from the contraventions by the Company pleaded in Sections V to VII of the accompanying Commercial List Statement; and
 - c. are not any of the following:
 - i. a related party (as defined by section 228 of the *Corporations Act 2001* (Cth) (**Corporations Act**) of the Company;
 - ii. a related body corporate (as defined by section 50 of the *Corporations Act*) of the Company;
 - iii. an associated entity (as defined by section 50AAA of the *Corporations Act*) of the Company;
 - iv. a former officer or close associate (as defined by section 9 of the *Corporations Act*) of the Company;
 - v. a Chief Justice, Justice or Registrar of the Supreme Court of New South Wales or the High Court of Australia; or
 - vi. a partner or employee of, or other legal practitioner engage by, the law firm Piper Alderman,

(collectively, **Group Members**).

FINAL RELIEF

- 1 On the grounds stated in the accompanying Commercial List Statement, the Plaintiff claims, on its own behalf and on behalf of Group Members:
- a. An order, pursuant to section 1317HA of the Corporations Act, that the Company compensate the Plaintiff and Group Members for the damage suffered by them which resulted from the Company's contraventions of section 674(2) of the Corporations Act.
 - b. An order that the Company pay the Plaintiff and Group Members compensation pursuant to:
 - i. section 1041I of the Corporations Act;
 - ii. section 12GF of the *Australian Securities and Investments Commission Act 2001 (Cth)*;
 - iii. section 236 of the Australian Consumer Law (being Schedule 2 of the *Competition and Consumer Act 2010 (Cth)*).
 - c. An order that the Company pay the Plaintiff and Group Members compensation pursuant to section 729 of the Corporations Act by reason of the Company's contraventions of section 728 of the Corporations Act.
 - d. Interest.
 - e. Costs.
 - f. Such further or other relief as the Court determines appropriate.

COMMON QUESTIONS

Capitalised terms have the same meaning as in the Commercial List Statement.

The questions of law or fact common to the claims of the Plaintiff and Group Members are:

- 1 Whether the Company contravened its continuous disclosure obligations in relation to its failure to inform the market about:
 - (a) the Solar Project Information;
 - (b) the Cash Flow Information;
 - (c) the Insufficiency of Entitlement Offer Information.
- 2 Whether the Company engaged in conduct that was misleading or deceptive or likely to mislead or deceive:

(a) in respect of its failure to inform the market about :

- i. the Solar Project Information;
- ii. the Cash Flow Information;
- iii. the Insufficiency of Entitlement Offer Information;

(b) by making the 28 August 2018 Representations.

3 Whether the Company contravened section 728 of the Corporations Act by:

(a) its omission to include in the Prospectus for the Entitlement Offer:

- i. the Solar Project Information;
- ii. the Cash Flow Information;
- iii. the Insufficiency of Entitlement Offer Information;

(b) including the 28 August 2018 Representations in the Prospectus.

4 Whether the Company's contraventions caused the Plaintiff and Group Members to suffer loss and damage.

5 The correct measure of compensation for which the Company may be liable to the Plaintiff and Group Members?

INTERIM RELIEF

1 The Plaintiff be granted leave to commence these proceedings against the first defendant pursuant to section 500(2) of the *Corporations Act 2001* (Cth).


2 Any other order the Court thinks fit.
